TERMS AND CONDITIONS:

The following terms and conditions set forth an agreement under which Invasion Snow Tours, 5080 Robert J Mathews Parkway, El Dorado Hills, CA 95762, in return for the payment of the tour package price, agrees to provide you (the participant) this non-transferable tour package. Please note that if you are under 18 at the time of signing the application, your parent(s)/guardian(s) must also sign the application. Your signature, and that/those of your parent(s)/guardian(s) if applicable, on the application for this trip constitutes agreement to these Terms and Conditions for all purposes. Invasion Snow Tours will not be responsible for forged signatures on the application. If you travel without a required parent(s)/guardian(s) signature on this application, your participation on this trip will constitute an implied consent on the part of your parent(s)/guardian(s). This application is for U.S. order only. All prices stated in this brochure are in U.S. funds (USD) and represent a discount for cash payment.

RESPONSIBILITY - Invasion Snow Tours hereinafter referred to as Invasion Snow Tours, arranges with its affiliated companies to provide you with transportation and hotel arrangements. Although Invasion Snow Tours acts as an agent and takes great care in choosing the transportation carrier and hotel, we do not control them, and therefore cannot be responsible for their acts or omissions. All coupons, receipts, discounts, and tickets issued by these suppliers shall be subject to the terms and conditions of the applicable supplier. We cannot assume responsibility for any claims, losses, damages, costs or expenses arising out of injury, accident or death, damage, loss or delay in baggage or other property, or delay, inconvenience, loss of enjoyment, loss of pay, upset, disappointments, distress or frustration whether physical or mental resulting from: mechanical breakdowns, government actions, strikes, lockouts, war, weather, overbooking, or other factors beyond our control. If forces beyond Invasion Snow Tours control, i.e., storms, road closures, transportation strikes, etc., cause the trip to be extended, the participant must pay all extra costs associated with such trip extension, i.e., extra lodging, meals, and transportation. Alpine sport activities (skiing, snowboarding, ice-skating, snowmobiling, et al.) are considered high risk and may result in damage/injury to you and/or others. Participation is voluntary and is entirely the responsibility of the participant. Invasion Snow Tours cannot assume responsibility for injury to you or others, nor can we assume liability for your actions nor the actions of other participants or non-tour participants. Participant is responsible for any/all necessary documentation needed to enter Canada from the U.S. Invasion Snow Tours is not responsible for lost or stolen baggage, ski or snowboard equipment, or any other personal items brought on the trip. In the event of overbooking, Invasion Snow Tours reserves the right without liability, to accommodate the group or any portion thereof, in alternate hotels/bus charters of equal or superior quality without penalty or at no additional costs to the participant. Price increases may include: fluctuations in currency valuation, fuel surcharges, increases in Government and security fees, not meeting program minimums.

PRICES - Prices in brochure are based on quad occupancy for standard rooms. Prices are based on tariffs as of August 1, 2008 and are subject to change. Price does not include refundable hotel security deposit (\$35), cancellation insurance, or event package. Price inclusions are listed in the brochure and are limited to what is printed. Price listed in brochure is based on a cash-discount. Credit Card price is \$15.00 more than published cash discounted price. All other expenses/costs are the responsibility of the participant. Price increases may include: fluctuations in currency valuation, fuel surcharges, increases in Government and security fees, not meeting program minimums.

DEPOSITS/PAYMENT - Full program registration requires a completed, legible application and a \$100.00 deposit. The deposit reflects the administrative cost of securing hotel and transportation space. The deposit is non-refundable and non-transferable. Invasion Snow Tours is not responsible for forged or misdirected applications. You will receive statements outlining your payments. Payments are to be mailed until balance is paid in full. Failure to follow payment schedule may result in late fees and/or cancellation. Applications will be processed on a first-come first-served basis. Payments may be made by personal check, cashier's check or money order for cash discounted price. If you are paying by credit card, you must pay in full at the time of application and note that the price is \$15.00 higher than the published cash discounted price. Invasion Snow Tours does not accept credit card payments/deposits over the phone must be in writing or done over the Invasion Snow Tours Website. Invasion Snow Tours is not responsible for, nor does it accept cash payments. Final payment may be required in the form of a cashier's check or postal money order and must be received to Invasion Snow Tours' office on or before final payment date. Reservations received after the final payment deadline requires immediate full payment in the form of a money order, cashier's check, or credit card. Late payments and new registrants received after the final payment deadline are assessed a \$35 late fee. Invasion Snow Tours reserves the right to charge the participant \$35 for returned checks, incorrect/refused credit card payments, itinerary changes, and accounts which become delinquent. Payments for reservations that cannot be accommodated will be returned within fourteen (14) business days, or with your authorization Invasion Snow Tours will retain the deposit and place your name on a waiting list in case other passengers cancel reservations. If participant is paying by credit card, the entire trip price including full payment of trip choice, refundable security deposit (\$35), non-cash payment fee (\$15), and cancellation insurance (\$30) will be charged to the credit card. If the cancellation insurance is not desired, you can notify in writing Invasion Snow Tours prior to final payment date and the charge for the insurance (\$30) will be refunded.

CANCELLATIONS/REFUNDS - Cancellations must be made in writing to Invasion Snow Tours' Main Office. Invasion Snow Tours requests that all cancellations be sent return receipt requested. Notice of cancellation must be signed by the participant who initiated registration, must be legible, and must include a complete address and a phone number corresponding to the initial application. Once a notice of cancellation is accepted and deemed eligible for a refund by Invasion Snow Tours' office, the appropriate refund will be mailed within 45 days. No refunds will be issued from verbal cancellations given by student organizers or Invasion Snow Tours staff. The following cancellation schedule will apply on all cancellations, including those due to unexpected circumstances. Your deposit is non-refundable and non-transferable. Cancellations by participants between time of registration and final payment date incur a \$100 penalty plus any additional fees charged by the hotel and bus company. Cancellations by participant made after final payment date and no-shows receive no refund regardless of reason on. No refund will be made for services/accommodations included but not used by participant. Optional Cancellation Insurance is strongly recommended.

TRIP CANCELLATION/INTERRUPTION/LOST BAGGAGE INSURANCE - Offered by Invasion Snow Tours through Travel Insured International, is a discounted trip protection insurance policy to cover your trip costs in case of cancellation for a stipulated reason. The cost is \$30.00 and will cover up to \$500.00 in cancellation/interruption costs. A brochure outlining the coverage's will be mailed to you. This insurance coverage will be automatically added to your invoice for your convenience. If you do not wish to have the coverage and take full financial responsibility for your tour, simply pay the final amount less the \$30 insurance cost by final payment date and the insurance will be removed.

SELLERS OF TRAVEL - Invasion Snow Tours is registered with the State of Washington as a Seller of Travel. Registration # 601-744-577. Invasion Snow Tours maintains a local Washington Bank account (Western Bank #203-00578401) to deposit clients' payments pending distribution to suppliers.

MEDICAL RELEASE/INSURANCE - By signing the application, the participant represents to Invasion Snow Tours that he/she is in good health and has no medical condition or disability, or need for prescription medication, which would require special attention on the trip (unless written notification is made to Invasion Snow Tours' office). If the participant becomes ill or injured while on the trip, the participant and his/her parent(s)/guardian(s) agree that Invasion Snow Tours shall have the right, but not the duty, to take reasonable action to secure emergency medical attention and/or transportation for the participant. The participant agrees to immediately inform Invasion Snow Tours of any injury or illness incurred during the trip and to pay for any expense incurred for such medical attention, transportation, or other related emergency services.

TRIP RULES AND REGULATIONS - Invasion Snow Tours reserves the right to enforce reasonable rules and standards of conduct to facilitate the participant's and others' well-being and enjoyment of the trip. Failure to comply with such rules and standards may result in the participant being barred from participating on the trip. Invasion Snow Tours will not tolerate any participant using or possessing illegal substances or weapons, underage drinking of alcohol, fighting, theft, or vandalizing or destroying other's property. Subject to applicable law, Invasion Snow Tours reserves the right to reject any person as a trip participant at any time prior to or during the trip. If necessary to enforce its rules and regulations, Invasion Snow Tours will, at its sole discretion, have the participant removed from the hotel and/or removed from the tour group, at the participants' sole cost and expense, without subsequent refund.

BUS TRANSPORTATION - Transportation supplied is subject to any foreign government(s) involved granting operating rights, and subject to all applicable U.S. and foreign laws, regulations, and treaties governing ground transportation. Invasion Snow Tours reserves the right to substitute licensed transportation providers and/or to change the bus type, capacity, and routing. No refund will be given for such substitutions or changes. Transportation pick-up points will be determined by Invasion Snow Tours. It is the responsibility of the participant to be at the pick-up point at the time and day specified (to be determined prior to the trip). You will be notified when and where the pick-up points are located. Participant agrees to be solely responsible for boarding all transportation on time with picture identification and participant/parental consent/rules form. Invasion Snow Tours shall not be obligated to make alternative arrangements for missed transportation.

DAMAGE/SECURITY DEPOSIT - A \$35 per person, refundable security deposit is required by each hotel. This refundable deposit is not included in the published price nor is it part of the initial deposit, but is required to be paid to Invasion Snow Tours by the final payment date. The deposit is refundable as long as there is no damage done to the hotel room or the common areas of the hotel for which travelers are responsible. Refunds will be issued approximately 45 days after trip return. NOTE: Damage costs will be the responsibility of all persons occupying room.

ENTIRE AGREEMENT - This agreement and the trip brochure constitute the entire agreement between the parties.
